The Week That Was

- ▣ Seaside, BIO – Before In & Out
- ▣ Water Rate Qs & As – Some questions unanswered, some answers lead to more questions. The issue will return later in the year.
- ▣ Well, That's Quite An Office Location – Seaside County Sanitation District staff and the District Board Chair met at Marina Coast Water District (MCWD) HQ to discuss the future of sewer service within the former Fort Ord area. MCWD has forwarded a technical report for staff to review and comment on.
- ▣ PG&E Tree Removal Plan Under Review - Staff is working with PG&E to determine the extent of work necessary to ensure gas line safety. PG&E is proposing to remove trees near the underground high-pressure gas main running through Seaside generally along the historic Highway 1 alignment (i.e. Fremont Blvd is included in this alignment).
- ▣ BAR Meeting Cancelled - The Board of Architectural Review meeting that was scheduled for March 16, 2016 to receive design recommendations from the BAR on the Specific Plan was canceled. The meeting was canceled at the direction of the City's legal counsel based on determination that the CEQA process for the Environmental Impact Report must first be completed before the BAR makes any recommendations to the Planning Commission and City Council on the Specific Plan.
- ▣ Thanks Mayor Rubio & Councilmember Pacheco – For attending the Seaside Spartans home baseball opener. The dugout was abuzz with “the Mayor is here” excitement. Stop by again on April 29 when Alisal returns, we don't commit six errors, and win.

The Week(s) Ahead

- ▣ Tuesday. Just saying.
- ▣ Better Living Through Better Conduit - PG&E will be replacing conduit in the sidewalk to Del Monte Boulevard near Toyota Dealership.
- ▣ State Visits - The State Water Resource Control Board will be performing an audit of the Seaside Municipal Water System on March 29.
- ▣ CIP Update In Progress - Engineering staff will be sending out requests to all departments for proposed project for consideration in updating the CIP.

- ▣ California American Monterey Peninsula Water Supply Project - Staff is working with Cal Am to determine the extent of work within the City of Seaside. Cal Am is proposing to install a water main running through Seaside along Lightfighter Drive then to General Jim Moore Blvd then to Hilby Avenue and then to Fremont Blvd. Cal Am has submitted a request to acquire land in the FORA lands east of General Jim Moore Blvd above Hilby for a proposed water reservoir.
- ▣ Senior Assisted Living & Memory Care Project – We’ve released a Notice of Intent to adopt a Mitigated Negative Declaration for the Senior Assisted Living & Memory Care Project for a 30-day public review period beginning on March 18, 2016 and ending on April 18, 2016. The project site is located on the Shoppette Parcel at the intersection of Monterey Road and Coe Avenue, 550 Monterey Road.
- ▣ Seaside Staff Leading - Sharon Mikesell, Economic Development Analyst, will be attending the Central Coast College annual Luncheon Advisory Group meeting at their campus in Salinas today. The College invites representatives from a variety of agencies and employers to give input regarding what the local community is looking for so that they can continually improve their curriculum to meet the needs. Sharon will be sharing the results of our CALED Award of Merit winning Business Survey with the group.

- ▣ B Shift (14%) - Right door, wrong rig. I’m an idiot could be one explanation. Another could be that Engine 6211 and 6212 look exactly alike, and 6212 is on the Fire Station apron while 6211 is still in the station when the alarm goes off. Training on the enclosed space entry equipment comes to an abrupt end as we head off in 6212 on the way to a bicycle accident.

Captain Sullens is kind enough not to mention the wrong rig thing. Perhaps he didn’t see it. But he does remind me to take off the headset before I get out on scene. So maybe he did.

There could be worse places to take a tumble on a bike. Fort Ord Dunes State Park is gorgeous today, and its beauty was the siren song to the crash. Here’s another reason to wear a helmet on a bike. It won’t fly off in the wind, and you won’t reach for it and lose control of your bike. When things go wrong in an instant, public safety employees get the call. They drop what they are doing, get there as fast as it is safe to do so, and help as best they can.

IAFF #17 President Jason Roth once explained firefighters to me as thoroughbreds; explaining that they're constantly training for high performance runs, and that's not inexpensive. The bike accident victim is taken good care off and we're back at the station for a few minutes before both Shift B companies head out to work through some complications with a training exercise scheduled for tomorrow. The building is complicated; a mix of commercial and residential uses, assembled in stacks like Lego blocks. The guys are trying to figure out how best / fast to lay hose to attack fires originating in various locations.

The three dimensional race against time puzzle has me asking two questions. The first is how do they figure it out when they don't get to see it in advance. At night. In the rain and fog. Before I can ask the second question or get a full answer to the first, the radios squeal and we're off to another call. We run (I won't say thoroughbred but certainly not Clydesdale) several hundred feet to 6212 and head off to another medical call. We arrive and I see the Sunday PD shift assignments haven't changed since last week. A man needs help and help is provided, with skill and empathy.

Two training assignments. Both interrupted by calls. President Roth, proved right again. All the while, Battalion Chief Blaha's lasagna is baking. There was one funny smoke filled moment in the kitchen, but dinner arrives without incident or another interruption. The eighteen pounds of cheese, marinara and noodle is consumed as heartily as the stories of less than pleasant medical calls are told. They're a great group of guys and, as I noted as we were heading back to the station from a call, it was an honor to ride with them.

Stay safe.

▣ Errors of Attribution, Plaguing Mankind Since Grunts Were Invented – Douglas County sent me to school once (a fancy school, too) and I learned something.

Most miscommunication is self-inflicted. Somebody will say or do something. You may witness it, or it may be described to you. You invent in your head the reason why somebody said or did this thing, because that's what we do. Something happened. Must be a reason. If I don't know the reason, I'll tend to invent one. Trouble is, the invented reason could be completely the opposite of the actual reason.

It's hard-wired into us; this making sense of the world, attributing intent to actions and words and believing we're right thing. There's no easy or permanent fix. Benefit of the doubt is a good starting position, though.

Saved you about twelve grand (and some inadvertent disagreements) right there.

Active Shooter Training

On March 16th, members from the Special Response Unit (SRU) and Seaside Fire Department conducted tactical response training. This specialized training focused on a joint response to an active shooter with multiple victims. Local communities will be preparing for a drill next month. This type of co-operational training will build on our ability to respond to an event and utilize public safety personnel effectively at a traumatic scene. Future training will help drive policy, response and equipment needs for an active shooter incident.
